This Privacy Notice sets out how we collect, use, manage and protect the personal data or information that we may collect from or about you. It applies to all users whose data may be handled by [Zhongming Luo]("we", "us", or "our") through the use of this [Skincare Timer]("App" or "Service").

1. How We Use Personal Information

We use your personal information to operate, provide, and improve the App. Our purposes for using personal information include:

- to provide and deliver our Services to you.
- to measure use of, analyze performance of, fix errors in, provide support for, improve, and develop the App.
- to recommend our Services that might be of interest to you, identify your preferences, and personalize your experience with our Services.
- in certain cases, we have a legal obligation to collect, use, or retain your personal information.

2. Personal Information We Process

We may collect a variety of personal information from or about you or your devices from various sources, as described below:

- the type, version, brand, language and operating system of device.
- the type and operator of network (such as Mac address).
- device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- behavioral usage of the App.
- email address.

3. When We Disclose Information

We may disclose your data to third parties in the following circumstances:

third-party service providers who provide the App security,
 application development, hosting, maintenance, marketing,

- advertising, and other services in connection with the App.
- analytics services to access personal data to help us understand how the App is used and user preferences.
- if required to do so by law or in the good-faith belief that such action is necessary to comply with any applicable laws, in response to a court order, judicial or other government subpoena or warrant, or to otherwise cooperate with law enforcement or other governmental agencies.

4. Data Security

We use certain physical, managerial, and technical safeguards that are designed to improve the integrity and security of personal information that we collect and maintain.

5. Retention

We make reasonable efforts to retain personal information only for so long as the information is necessary to fulfil the purposes set forth in this Notice. When your personal data is no longer necessary for the purposes for which we process it, we will take measures to delete your personal data or keep it in a form that does not permit identifying you, unless we are required by law to keep your data for a longer period.

6. Children's Privacy

Our App is a general audience app not directed to children under the age of 13, and we do not knowingly collect data from children. If you become aware that your child or any child under your care has provided us with personal data without your consent, please contact us and we will delete any such data.

7. Third-Party Services

The App may contain features or links to websites and services provided by third parties. Any personal data you provide on third-party sites or services is provided directly to the operators of such services and is subject to those operators' policies, if any, governing privacy and security, even if accessed through the App. We are not responsible for the content or privacy and security practices and policies of third-party sites or services to which links or access are provided through the App. We encourage you to learn about third parties' privacy and security policies before providing them with personal data.
